Deposit is **not refundable** for any reason including weather. After price is determined, you will receive a Vendor Contract via email/mail for you to complete, sign and return with 50% deposit of total fee. Remaining balance will be due no later than the close of opening day. Vendors will not be able to set up unless a deposit and contract is received no later than September 30, 2009.
